## **Committee Reports:**

**Fire Chiefs**: John LaVenture – There was discussion regarding Central County dispatching; radio system; traffic signals and cisd.

Education Committee: Steve Gettemeier or John LaVenture – No report.

State Fire Marshals: Roger Herin – The annual conference was held August 3-5 – the minutes are posted on the website (fmamonline.com). The President's Award was given to Chris Gaut. The Ed Vinyard Award was given to Lloyd Montgomery.

State ICC Chapter: Paul Richards - No report.

**MABOI**: Bryan Kopp – The annual officers election will be tomorrow (Sept. 10, 2009) at the fire suppression systems seminar. The annual conference will be October 8-11, 2009 at Tan-Tar-A.

ICC: Ed Berkel – The annual business meeting and code hearings are coming up starting next month. Ed went over the process. Attendance in Baltimore is important. There was much discussion regarding the process, and the importance of attending and voting. It was approved by vote to fund travel and lodging expenses for two (2) members; and subsequently amended to fund up to \$3,000 for members travel and lodging.

Jefferson County Fire Marshals Assoc.: Lloyd Montgomery – There will be a firestopping class October 15 at Rock Community House 5 at 8:30 A.M. along with the regular meeting. Lloyd also reported that Rock Community is looking at adopting only the IFC, and enforcing all other codes as referenced by the IFC. Gene Robertson announced that High Ridge FPD has reduced their permit fees 50% until December 31, 2010 in an effort to stimulate growth.

Laclede Gas: Ron Chac - No report.

Missouri American Water: Ben Von Harz – No report. Lloyd Montgomery stated he has found that different water purveyors have different requirements for residential sprinkler supply. Chris Gaut is questioning whether Missouri American Water can require two meters. Much discussion ensued.

St. Louis Sprinkler Alliance: Wally Miller – Wally went over the schedule of side-by-side burns (see their website). He also stated that they are working on having one at the St. Louis HBA headquarters.

**AAGSL:** MJ Vance – No report.

**Code Review:** Steve Gettemeier or John LaVenture – They are done with the IBC and working on the IRC.

**BCRC:** Roger Herin – Roger stated that the BCRC is done with the IBC and IEBC, and is now working on the IRC. He distributed copies of two code change proposals – one dealing with common separation walls for townhouses; the other dealing with protection of lightweight construction. Both code change proposals were approve by vote to be sponsored by MFMA.

**MCRC:** Paul Mercurio – Paul stated that our mechanical code change proposal has not been reviewed yet.

#### Old Business:

**By-Laws:** Roger Herin – The proposed changes were discussed and distributed, and will be voted on at the next meeting.

**New Business**: It was reported that the ICC is coming up with residential sprinkler exam courses. Chris Gaut stated that NFSA does not support this program.

**Roundtable**: The NFSA monthly report was discussed. There was discussion regarding NFPA 13D sprinkler designer qualifications. A letter from MFMA to the State Board in support of proposed rule changes was approved by vote.

**Good of the Order**: Due to difficulties with the Secretary's e-mail system, it is recommended that all members sign up for the list-server to receive MFMA e-mails. Details on how to sign up will be sent to the membership.

**Announcements**: Rooms are now available at Tan-Tar-A for the 2010 FMAM conference. This will be the 25<sup>th</sup> anniversary conference.
