Jefferson County Fire Marshals Assoc.: Lloyd Montgomery – Rock Community FPD is looking to adopt the 2009 IFC with referenced I-Codes in February. Many of the other Jeffco districts plan to follow suit.

Lloyd warned of kitchen hood systems coming from China that are not listed and are not the proper gauge steel. Look closely to make sure the hood is compliant.
Jeffco would like to have a combined training class with MFMA from Zumwalt Corp. on Fire Doors.
